Fort Langley National Historic Site

About the Site

Fort Langley National Historic Site is a 19th century Hudson’s Bay Company trading post managed by Parks Canada. The site is located in Fort Langley village, a popular film location on the south bank of the Fraser River in the Metro Vancouver region of BC. The site consists of a historic fort (12 wooden structures surrounded by a log palisade, a grassy orchard area, a parking lot with picnic area, and a wooded waterfront property.

Applying to Film at Fort Langley NHS

1. Submit attached application.
2. We will provide a draft agreement. Work together with the Parks Canada liaison to adjust the details of your agreement, based on your needs and our site’s visitor needs and regulations. A **site visit** may be required.
3. Obtain comprehensive liability **insurance** naming **“His Majesty the King in right of Canada as represented by Parks Canada Agency”** as additional insured, indicating a combined limit of \$2,000,000 per incident (\$5 million/incident for larger productions), to be carried for the duration of the production on site.
4. At least three business days prior to your film date, supply:
 - **Proof of insurance**
 - **Damage deposit** of \$1000 (refundable if no damage is incurred)
 - **Payment** written to the **Receiver General for Canada**, or by credit card.
 - **Signed agreement** - your company must sign first, followed by the Parks Canada manager.

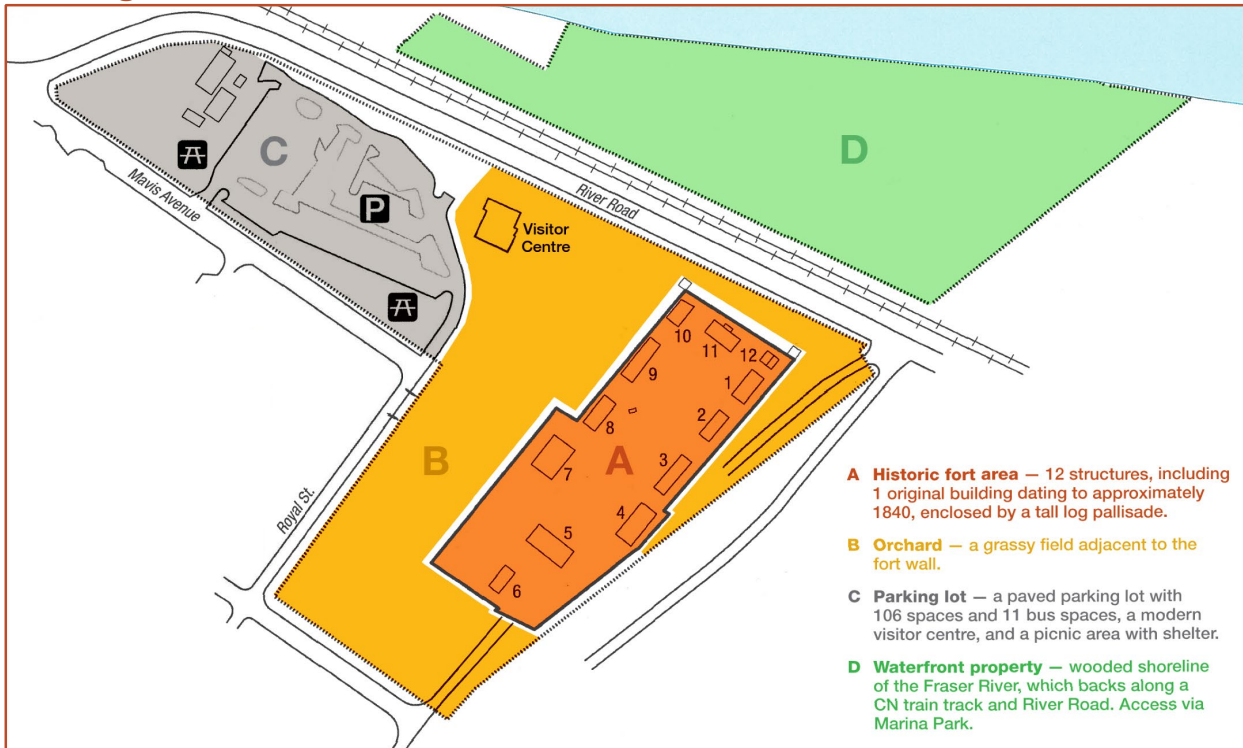
