

Green Point Campground

Welcome to Green Point Campground and Pacific Rim National Park Reserve! Parks Canada wants to make your stay enjoyable and memorable, and we need your help. You can help keep the campground running smoothly by following these guidelines and rules:

Check-in & check-out

- Check-in any time after 2:00 p.m.
- Register and pay fees at time of arrival.
- Maximum length of stay is 7 days.
- Campsite allocations may only be changed with prior approval of the campground attendant.
- Check-out time is 11 a.m. If re-registering please do so before that time. Camping space is in constant demand and unregistered campers will be asked to vacate.

Important safety information

- Always follow *Bare Campsite* procedures; staff may enter your site to check for and remove any wildlife attractants (see reverse for additional details).
- Never leave valuables in your unattended campsite or in your vehicle.
- Feeding any wildlife (including birds) is illegal and harmful.
- Dogs (and all domestic animals) must be on leash at all times in the National Park Reserve.
- Adhere to the posted speed limit of 20 km/h in campground.
- Fires are permitted in designated firepits only.
- Never leave your fire unattended.
- No burning driftwood, trees, downed wood, or other vegetation.

For drive-in sites only

- 6 people per site (exception: 2 adults with their dependant children to a maximum of 7 people).
- Maximum 2 tents or 1 RV/Camper and 1 tent.
- 2 vehicles per site, space permitting.
- Tarps, vehicles, and all other camping materials must be within the already cleared footprint of the campsite.

For walk-in sites only

- 6 people per site.
- Maximum 1 tent per site.
- No pets or stereos.

RVs and campers!

- Please use biological tank treatment products for odour control.

The Bare Campsite Program

You are camping in wildlife habitat!

We share this landscape with wild animals that depend on it for their food and survival, including black bears, cougars and wolves. The *Bare Campsite Program* is in place for your safety, and to keep the wildlife alive and wild. You play an important part in preventing the creation of food-conditioned animals.

- Keep picnic tables and campsites clean.
- When not in use (sleeping, leaving your campsite — even to use the washroom) you must store all attractants in a hard-sided vehicle, motorhome, trailer or campground food storage lockers.
- Do not store attractants in a tent or soft-sided trailer!

Examples of attractants

- Coolers – full or empty
- Food and condiments
- Garbage/wrappings/plastic bags
- Pet food/bowls
- Bottles/cans – full or empty
- Gasoline, oil, or other petro-chemicals
- Toiletries, sun lotion, insect spray
- Campstoves, barbeques
- Food preparation or clean-up items (pots, dishes, soap, dish cloths, tablecloth)
- Grey water pails

These are a few examples. Many other items can be attractants too. If you are not sure please check with campground staff.

- Keep food, including coolers, where it will not attract bears or other wild animals (wildlife pays the ultimate price if food association is established).
- Parks Canada staff patrol the campground regularly to ensure *Bare Campsite* policies are respected.
- If you return to your site and discover items missing, they may have been relocated to a wildlife-proof storage. Look for a notice, it contains further instructions on how and where you can claim those items and how staff can help.

Failure to comply with the requirements of the Bare Campsite Program may result in camping permit cancellation, without a refund, and may be charged under the Canada National Parks Act and Regulations.

Protecting nature

- Please place your tent on the established footprint of the campsite.
- Please do not scar or damage trees or shrubs.
- It is illegal to collect deadfall or driftwood for firewood, or cut down any brush, branches or trees within Pacific Rim National Park Reserve.
- Deposit garbage and recycling in proper disposal facilities.
- Leave wild animals, flowers and trees undisturbed.

Good neighbours

- Leave toilet buildings, tables and campsites clean—other visitors appreciate clean facilities too!
- Alcohol is not permitted in public areas (permitted only at your site).
- No excessive noise at any time. Respect quiet hours 11 p.m. to 8 a.m. —no visitors during this time.
- Beaches are to be vacated between 11 p.m. and 8 a.m. to allow wildlife to use these spaces.

Failure to comply with these or any other regulations in effect within Pacific Rim National Park Reserve may result in the cancellation of your camping permit, prosecution and/or eviction. When a permit is cancelled, no refund will be given for the unused portion of the camping permit.
