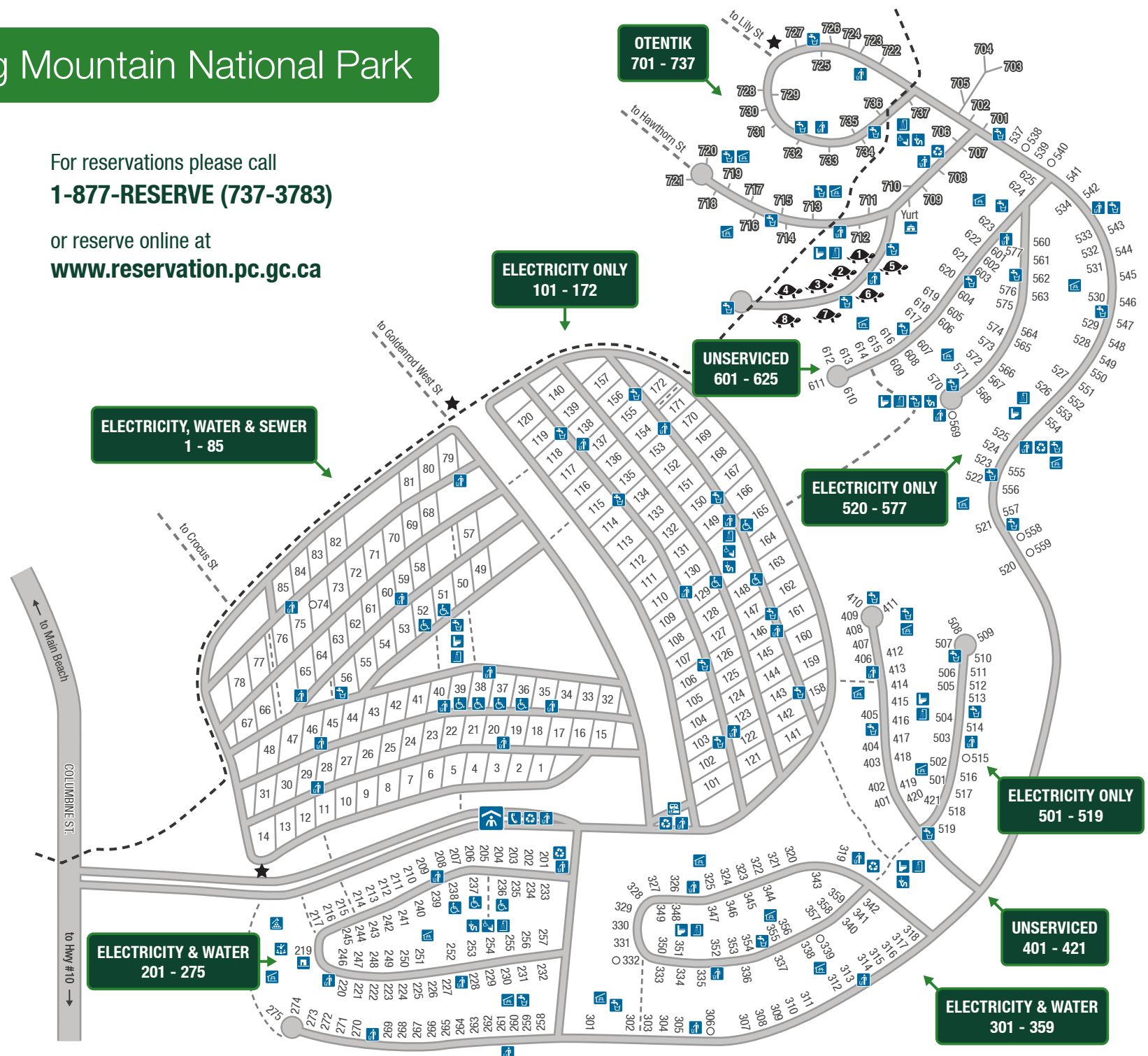

CAMPING INFORMATION

Campsite Check-in: after 2:00 PM.

Accommodation Check-in: after 3:00 PM.

Check-out or re-register prior to 11:00 AM. Camping space is in constant demand and unregistered campers will be asked to vacate.

Accommodations must be checked-out by 11:00 AM; please return the key to the kiosk drop-box. You must notify the campground of **cancellations** before 11:00 AM on the day you wish to depart to be eligible for a refund.

Campground entry gate is closed to vehicles from 1:00 AM to 7:00 AM.

Firewood may be purchased from the wood yard with cash, credit or debit.

All Water in Wasagaming Campground is potable. We advise that you do not fill tanks at the dump station due to the risk of cross-contamination.

CAMPGROUND REGULATIONS

The **registered permit holder** is responsible to ensure that their group and visitors to their campsite do nothing to interfere with the quiet, peaceful use and enjoyment of Riding Mountain National Park by any other person.

This includes failure to comply with bare campsite policies, damaging property, loud music, insulting or obscene language, fighting, drunkenness, screaming etc. Failure to comply with these and any other regulations in effect within Riding Mountain National Park may result in the **cancellation of the camping permit, prosecution, and/or eviction**. No refund is issued in the event of a permit cancellation.

1 Noise shall be kept to a minimum at all times. **Quiet hours** are from 11:00 PM to 7:00 AM. Visitors are not permitted during these times. An **alcohol and cannabis consumption ban** is in effect during the quiet hours.

2 Camping equipment must stay within the impacted area to avoid destroying vegetation. Do not cut through campsites or create shortcuts as this reduces privacy between campsites.

3 Fires are permitted only in designated fire places. **Never leave a fire unattended.** Campfires and major light sources must be **extinguished by 1:00 AM**. Do not burn food refuse or garbage.

4 Do not bring firewood from other areas into Riding Mountain National Park. Foreign firewood may harbour **invasive species** that have the potential to destroy entire forests.

5 It is illegal to collect plants and berries, as well as collect deadfall for firewood or cut down trees within Riding Mountain National Park.

6 A maximum of 6 people and 2 vehicles are allowed per campsite. Please keep all camping equipment and vehicles on your campsite and clear of the roadways. Campground attendants can assist you to find additional parking nearby if required.

7 Each site is allowed a **maximum of 2 sleeping tents or 1 tent and a wheeled camping unit**. With the exception of dining tents, no additional tents are allowed at our accommodations.

8 Pets must be kept leashed at all times and under control by their owners. For the safety of your pet, wildlife and neighboring campsites, pets cannot be left unattended. Respect others by cleaning up after your pet and keeping noise levels to a minimum. Pets are only allowed within designated pet-friendly accommodations.

9 Fireworks and firearms are not permitted. Persons using or in possession of fireworks or firearms are subject to federal prosecution.

Wasagaming Campground is located on Treaty 2 Territory. We honour Treaties 1, 2 and 4 and acknowledge and appreciate the close partnership with the Anishinabe Coalition of First Nations with interest in Riding Mountain National Park.

10 “BARE” CAMPSITE REGULATIONS

Wildlife attractants must be stored in a bear-proof area! Safe places to store wildlife attractants include:

- Inside a hard-sided trailer
- Inside your vehicle
- Inside a bear-proof food locker
(located in kitchen shelters throughout the campground)

What is a “Wildlife Attractant”?

This includes anything that could be visually appealing to wildlife and/or carries a scent:

- All food & beverages
- All coolers (even empty ones)
- Mini fridges
- Cooking equipment and dishes
- Toiletries such as toothpastes and lotions
- Candles, soaps, detergents, and sprays
- Pet food and pet toys
- Garbage and recycling

What do I need to do to follow the bare campsite regulations?

- Keep a clean campsite
- Day or night, all visual or scent attractants are safely stored when you are away from your site or asleep
- Dispose of garbage & recycling in the bear-proof bins provided
- Dispose of waste water at designated grey water locations
- Clean barbecues and cook-stoves after each use
- **Never** store wildlife attractants inside a tent, tent trailer, oTENTik or yurt

If wildlife attractants are left unattended at your campsite, park staff have permission to enter your site and secure these items. **Failure to follow the “Bare” Campsite Regulations are grounds for permit cancellation.**
